Crumpton House - Built in 1852 by Green Rives for his daughter, Lucy Wyche Rives, wife of Dr. Ulmer John Crumpton. Occupied continuously since by decendants of the family. Currently owned by Howard Crumpton Oliver and his wife Ann.




#### **Underwood House**

#### **Belvoir Plantation**

Belvoir Plantation was built circa 1840 by Judge Reuben Saffold who served as Chief Justice of the Alabama Supreme Court from 1834-1836. He settled in Dallas County in 1825 where he later built Belvoir. He died in 1847 and he and his wife are buried in the family cemetery behind Belvoir. The house was in a state of disrepair when it was added to the places in peril list by the Alabama Historical Commission in the 1990's. The house was purchased in 1999 by Bess and Arthur Collias of Canton, Ma. and restored to it's original grandeur as you see it today.



### Mt. Carmel Church

Built 1852 - Initial SDHPA Project 1998 - present.



#### **Butler-Rives House**

Butler-Rives House - The home was built in 1830, probably by Mr. Charley Butler. It was used primarily as a plantation house; in addition, however, it served as a boarding stop for travelers from the Greenville area on their way to Benton to catch steamboats for Mobile and New Orleans. The house burned early in 1896 but was rebuilt later that year using doors salvaged from the prior structure. The original barn and a slave cabin, also built in 1830, remain near the home. The Rives family purchased the property in 1948; Rodney Rives and his wife, Donna, are the current residents.
